Mine statutory positions portal: Navigating the Work Health and Safety (Mines) Regulations 2022

This guide has been prepared to provide an overview of and the Work Health and Safety (Mines) Regulations 2022 (WHS Mines Regulations).

Many of the exam questions will have key terms which are defined in the *Work Health and Safety Act 2020* (WHS Act) or WHS Mines Regulations. Many of these key terms appear in the WHS Mines Regulations under the section heading 'Terms used'.

Using the key terms and this guide will assist you to locate the regulation needed to answer each exam guestion.

The WHS Mines Regulations are written in the following structure, which is common across legislation:



Groups of regulations can be organised into parts. Parts are sequential and may be broken into divisions and subdivisions. Chapters may be used for large and complex legislation.

Each part, which is sequentially numbered, is made up of a division. Divisions restart at 1 for each part, and some divisions have subdivisions.

Each division or subdivision is made up of regulations, which are numbered from 1 to 749. Not all regulations of the WHS Mines Regulations are used. Regulations are broken down as follows:



The convention when citing a regulation in writing is 'r. 56, r. 63A and so on. The figure below is an example taken from the 'Contents' of the WHS Mines Regulations.
